<input type="checkbox"/> January 11, 2023	<b>Complaint Citations</b> <i>There have been 3,287 complaint surveys in Ohio compared to only 417 annual surveys in 2022. This session will review how the Ohio Department of Health prioritizes complaint calls and the survey protocol for investigating complaints. Top cited areas will be discussed with citation examples given. Regulatory language related to grievances will be shared. Best practices in complaint resolution and QAPI considerations will be discussed.</i>
<input type="checkbox"/> February 8, 2023	<b>Immediate Jeopardy</b> <i>The Ohio Department of Health shared with LeadingAge Ohio their concerns with recent immediate jeopardy citations including trends not previously found in Ohio. This session will include a review of the trends in immediate jeopardy and harm citations. Top cited areas will be discussed with citation examples given. Self-reported incident documentation will be discussed. Immediate plan of correction considerations will be identified. Regulatory language and recommended standards of practice will be shared.</i>
<input type="checkbox"/> March 8, 2023	<b>Activities of Daily Living Decline</b> <i>Activities of Daily Living (ADL) decline is the fourth most frequently cited F-tag in Ohio for 2022. This session will cover how noncompliance results in citations. CMS' focused areas of decline in mobility and ADL will be shared. The surveyor protocol in determining if a decline is avoidable or unavoidable will be explained. ODH updates and current citation trends in Ohio will be discussed.</i>
